Norris provides final oral report to The Chapel Board

**Jan. 6, 2021**  
Camardo makes personal report to Amherst police...

Camardo threatens Wes Aarum with firing

**Jan. 6, 2021**  
Norris makes personal report to Catt. County Sheriff against Wayne

**Jan. 11, 2021**  
Camardo threatens Wes Aarum with firing again

**Jan. 6, 2021**  
Norris provides 14 names of complainants to Sheriff, all still anonymous to public

**Jan. 11, 2021**  
Norris files oral complaint with NY state Child Protective Services against Wayne

**Jan. 24, 2021**  
Camardo holds special meeting of congregation; Camardo message: Wayne is guilty

**Feb. 2021**  
Norris files oral complaint with Catt. County Dept of Health against Wayne

**Jan. 12, 2021**  
Wes Aarum resigns his job at The Chapel

**Jan. 25-30, 2021**  
LWM works on investigation of Norris's anonymous complainants.

**Feb. 5, 2021**  
Catt. County Sheriff closed case on Norris complaint; no interview of Wayne no action

**Feb. 10, 2021**  
LWM issues 20-page report on anonymous accusers; describes 3 "possibles" – not by name; concludes no substantial evidence

Joy Wigglesworth . McCullough announces she is no longer anonymous

**Apr. 2, 2021**  
Arcade Herald reports Chelsea Carnahan as complainant

**Apr. 5, 2021**  
Reporters get response to FOIL request with names of 14 complainants

**Apr. 7, 2021**  
Buffalo News report, complainants all anonymous

NY Dept. of Health closes Norris complaint; No interview of Wayne; no action

**May 14, 2021**

Amherst Police Dept. closes investigation of new complaint; No interview of Wayne; no action.

**May 30, 2021**

All official activity on complaints now closed; No interviews of Wayne; no action.

**June 2, 2021**

LWM and Wayne Aarum file complaint in Erie County Supreme Court against The Chapel and John Camardo

COMPLAINANTS: 15 KNOWN & 8 ANONYMOUS

**May 5, 2021**

Email from Michelle Bonifacio Poulsen saying no longer anonymous, but her name had already been given to reporters by sheriff's office .

**May 14, 2021**

Complaint received by Amherst Police Department; complainant sent by Norris; name withheld

**June 2, 2021**

USA Today publishes article quoting 7 of 14 complainants

**June 4-24, 2021**

Other non-Chapel complainants join via news articles and social media posts
